### **Commitment to achieving Net Zero**

Colours Decorating Ltd is committed to achieving Net Zero emissions by 2050 at the latest.

### **Baseline Emissions Footprint**

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

Additional Details relating to the Baseline Emissions calculations.

Our baseline gives a post-pandemic guide to our emissions; our premises was fully occupied and in use 5 days a week. We have not recorded emissions prior to this date and have used The Carbon Trust's calculator to determine our total emissions based on Scope 1 and Scope 2 spend in 2022, and the carbon footprint calculator at <a href="https://www.carbonfootprint.com/">https://www.carbonfootprint.com/</a> to determine our Scope 3 emissions.


### **Emissions reduction targets**

To continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 60 tCO₂e by 2027. This is a reduction of 25%

### **Completed Carbon Reduction Initiatives**

The following environmental management measures and projects have been completed or implemented since the 2021 baseline. The carbon emission reduction achieved by these schemes equate to 11 tCO<sub>2</sub>e, a 12%ge reduction against the 2021 baseline and the measures will be in effect when performing the contract

- Our environmental management system across the UK is UKAS certified to ISO 14001 and is audited annually. It focuses on actions and objectives in the short and long term that will have the most significant environmental impact.
- Revisions of our travel and vehicle policies to support decarbonisation
- Introduction of a complete EURO 6 rated fleet to reduce and conform with emissions
- Flexible working policies are now in place, reducing the use of gas, electricity, and water
- Change of offices to modern premises to reduce energy consumption
- Introduction of new EV vehicles to the fleet
- Roll out of behavioural training, in person and e-learning to support reduction in our environmental impact
- Scheduling of more electronic meetings to reduce travel emissions
- Insuring van share systems for employees based on the same projects

#### In the future we hope to implement further measures such as:

- Support for green commuting (incl. cycling, car sharing and green public transport).
- Roll out of additional EV vehicles to the fleet
- Change of offices to modern premises to reduce energy consumption
- Require all sub-contractors/suppliers to report their scope 1 and 2 carbon and work along side them to reduce carbon consumption
- Continue our focus on local materials, supply chains and labour

### **Declaration and Sign Off**
